1. To be eligible, all bowlers must be a grandparent or step-grandparent and also must be registered with USBC through Ocean County USBC Association. **If a bowler is not registered but wishes to bowl in this tournament, you must pay an additional participation fee of \$5.00. and have a verified average for 21 games or more from an Ocean County league.** (Payment of this fee entitles the entrant to participate in this specific tournament only and subjects them to all USBC rules and jurisdiction for this tournament.) Fee of \$5.00 must be paid with this tournament entry.
2. Entrants may only bowl once in this tournament.
3. All entries must be on an official entry blank. All bowlers must report at the lanes 30 minutes before scheduled time for bowling.
4. Entries will be scheduled according to requests if possible and in the order received. Lanes will be assigned by tournament manager.
5. The Committee is not responsible for errors made in averages in filling out the entry blank. The Committee reserves the right to refuse an entry or disqualify any entrant with just cause. If an illegal entry should be accepted through error, all fees paid on such entry shall be forfeited and score bowled declared null and void. Any appeal or protest shall be made in writing and submitted to the Ocean County USBC Association Board of Directors not later than 24 hours after the games have been rolled for scoring errors. Any other protest affecting eligibility or general playing rules must be confirmed in writing to the Tournament Director or the Local Association officials or the USBC before the payments are made. The decision of the Tournament Board of Directors shall be final unless an appeal is made in accordance with USBC rule 329.
