## TOURNAMENT RULES

1. To be eligible, all bowlers must be $\mathbf{5 0}$ years or older by the date of tournament, and also be sanctioned with USBC through OCUSBCA. If a bowler is not sanctioned but wishes to bowl in this tournament, You must pay an additional participation fee of $\$ 5.00$. (Payment of this fee entitles the entrant to participate in this specific tournament only and subjects him/her to all USBC rules and jurisdiction for this tournament) Fee of $\$ 5.00$ must be paid with this tournament entry.
2. Entrants may only bowl once in this tournament.
3. All entries must be on an official entry blank. All bowlers must report to lanes 30 minutes before scheduled time for bowling.
4. Entries will be scheduled according to requests if possible and in the order received. Lanes will be assigned by tournament manager.
5. The Committee is not responsible for errors made in averages in filling out the entry blank. The Committee reserves the right to refuse entry or disqualify any entrant with just cause. If an illegal entry should be accepted through error, all fees paid on such entry shall be forfeited and scores bowled declared null and void. Any appeal or protest shall be made in writing and submitted to the Ocean County USBC Association Board of Directors no later than 24 hours after the games have been rolled for scoring errors. Any other protests affecting eligibility or general playing rules must be confirmed in writing to the Tournament Director or Local association officials or USBC before payment is made. The decision of the Tournament Board of Directors shall be final unless an appeal is made in accordance with USBC rule 329.
6. Average to be used: (IN THIS ORDER) OCEAN COUNTY AVERAGES ONLY
A. Highest 2022-2023BOOK/LEAGUE AVERAGE for 21 games or more. If none use---
B. Highest 2023 SUMMER AVERAGE for 21 games or more. If none use---
C. Non Sanctioned Bowlers must have average verification for final average from 2022-2023 Season of $\mathbf{2 1}$ games or more. If none use---
D. Scratch Average of 230.

If a bowlers' average based on a minimum of 21 games is ten pins higher than their 2022-2023 average, this average must be used.

These rules pertain to REGULAR and SUBSTITUTE league bowling. USBC rules 319a-2, 319a-4, 319d, 319e do not apply. If incorrect average is submitted, the handicap will be changed to the correct average by the tournament director if possible. If not, the entry and fees shall be returned.
7. Premature termination of this tournament brought about by war, national emergency or emergency causes related thereto or there from fire, strikes, labor difficulties or other reasons beyond the control of the Ocean County USBC Association, shall cause the foregoing prize schedules to be prorated in accordance with the number of entrants who have bowled up to the time of termination.
8. The tournament is handicap with two divisions.
9. The tournament is based on $100 \%$ handicap of the difference of 230
10. There will be 2-4 applicants on each lane bowling a series of $\mathbf{3}$ games.
11. TIES: In the case of a tie for first place, individuals shall be declared "Co-Champions". First and second place money shall be equally divided. Awards for Co-Champions.
12. Bowlers arriving late will start to bowl in the same frame the other bowlers are bowling. No score for frames missed.
13. This tournament is a handicap tournament - with added prizes for the scratch high series and high game for both male \& female.
14. Pacers will not be permitted to bowl in this tournament.
15. ONLY AUTHORIZED BOWLERS AND PERSONNEL WILL BE ALLOWED IN THE BOWLING AREA. NO CHILDREN WILL BE PERMITTED IN THE BOWLING AREA AT ANY TIME.
16. No change will be made in entrant's scheduled time, except in case of emergency and must be approved by Tournament Director
17. Entry fee of $\$ 25.00$ must accompany this application. Mail entry form to Tournament Director. CHECK OR MONEY ORDER MUST BE MADE PAYABLE TO "OCUSBCA". Full fees must be included with entry application and check or they will be returned to entrant.
